- On January 1, 2020, the reporting person was granted restricted stock units, vesting in four annual installments beginning on the first anniversary of the grant date. Ten percent of the restricted stock units will vest on the first anniversary date of the grant, twenty percent of the restricted stock units will vest on the second anniversary date of grant, twenty percent of the restricted stock units will vest on the third anniversary date of grant and fifty percent of the restricted stock units will vest on the fourth anniversary date of grant. The restricted stock units will be settled in stock or cash at the issuer's election.
